RE: BOIL WATER NOTICE #5391 BRUNNER HILL WATER ASSOC - PWS ID # 837

The Arkansas Department of Health has confirmed the 'Boil Water' Notice issued by BRUNNER HILL WATER ASSOC for the Dolph area north ofRodney Cutoff Road on April 27, 2024. This order was issued as a precautionary measure because of the possibility that contaminated water may have entered the distribution system as a result of a main break.

Under the 'Boil Water' Notice, all affected customers are advised that the water may be unsafe for human consumption, and water used for drinking or food preparation must be boiled briskly for one (1) minute prior to use. All ice cubes should be discarded and only boiled water used for making ice.

This Notice will be lifted by the Department of Health when 1 set of 3 bacteriological samples indicate that the water is free of bacterial contamination and an adequate disinfectant level is established throughout the distribution system.

We recommend that you directly notify the news media.

#### FOR IMMEDIATE RELEASE

THE ARKANSAS DEPARTMENT OF HEALTH HAS CONFIRMED THE 'BOIL WATER' NOTICE ISSUED BY BRUNNER HILL WATER ASSOC FOR THE DOLPH AREA NORTH OFRODNEY CUTOFF ROAD. THIS ORDER WAS ISSUED AS A PRECAUTIONARY MEASURE BECAUSE OF THE POSSIBILITY THAT CONTAMINATED WATER MAY HAVE ENTERED THE DISTRIBUTION SYSTEM AS A RESULT OF A MAIN BREAK.

UNDER THE 'BOIL WATER' ORDER, ALL AFFECTED CUSTOMERS MUST BE ADVISED THAT THE WATER MAY BE UNSAFE FOR HUMAN CONSUMPTION, AND WATER USED FOR DRINKING OR FOOD PREPARATION MUST BE BOILED BRISKLY FOR ONE (1) MINUTE PRIOR TO USE. ALL ICE CUBES SHOULD BE DISCARDED AND ONLY BOILED WATER USED FOR MAKING ICE.

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL THE PROBLEM HAS BEEN CORRECTED, AN ADEQUATE DISINFECTANT LEVEL IS ESTABLISHED THROUGHOUT THE DISTRIBUTION SYSTEM, AND A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK.

THE BOIL WATER ORDER WAS DUE TO MAIN BREAK.
